

Building use procedures

The purpose of Providence Willamette Falls Community Center is to provide a location for the hospital's health education classes and employee trainings. The building is also available for use by non-hospital community organizations on an individual basis.

Business hours are Monday and Friday, 8 a.m. to 5 p.m., Tuesday through Thursday 7 a.m. to 8 p.m. For events outside of the normal business hours, an additional fee will be charged.

Providence Willamette Falls Community Center is a **tobacco free facility**.

All decorations must be pre-approved. No candles permitted in building.

The meeting leader and their guests are expected to follow all building procedures and to leave the building and its properties in the same condition as found or additional fees will be assessed, as well as exclusion from future use of the facility. The meeting leader is expected to communicate building policies to their guests.

All meetings are subject to approval. Space is not guaranteed until you receive confirmation either by phone or email.

Standard room set-ups are used at all times. Room assignments are decided by staff, based on group size, class function, and audio-visual requirements.

No Shows or cancellations of **72 hours** or less notice will be charged the full room rate.

Providence Willamette Falls Community Center charges for the use of audio-visual equipment. You are required to arrive 20 minutes prior to your event to learn how to use the equipment. Charges will be assessed for damage and/or improper use of equipment.

Parking is limited. There are 90 spaces available; carpooling is strongly encouraged.

Food Service Guidelines

Coffee, decaf coffee, tea, and ice water are available for \$12.00 per pot with advance notice.

Approved caterers who have met specific criteria have been trained to use our kitchen and facilities. You must directly contact the approved caterers to make arrangement for food service.

We encourage you to use Providence Willamette Falls Medical Center catering service for your event. Our chefs offer a full-service catering department for your guests to enjoy.

The kitchen area of the Community Center is not available for use by customers.

Drinks with lids are allowed in the auditorium, **food is not allowed**. The meeting leader is responsible to ensure their guests comply.

The meeting leader or their food service provider is responsible to ensure that all food/serving ware is disposed of. Spills should be attended to and reported.
